*Regional Transmission Organizations (RTOs) are seeking to address potential shortfalls in capacity on their systems. Three critical concerns for RTOs include (1) forecasted resource adequacy shortfalls, (2) challenges in processes to interconnect new capacity to transmission systems, and (3) immediate and future large increases in energy consumptions in transmission regions. Multiple RTOs are proposing policies such as Expedited Resource Adequacy Studies (ERAS) or other mechanisms to address these challenges. In this panel, RTOs will discuss these challenges and the status of proposals and current practices.*
