

# MID-GRID 2035 2.0 Quarterly Meeting – Kansas City Speaker Biographies

#### Chair Kayla Hahn, Missouri Public Service Commission

Chair Kayla Hahn was appointed to the Missouri Public Service Commission by Governor Michael Parson on June 1, 2023. Chair Hahn was appointed to a new six-year term on January 2, 2024. On February 6, 2024, she was named Chair of the Public Service Commission.

Prior to her appointment, Chair Hahn was on the Governor's senior staff team as Policy Director and had served as Senior Advisor and Policy Director for Governor Parson since August 2018.

As Policy Director, Chair Hahn helped lead the Governor's legislative agenda, prepare the Governor's annual budget recommendations to the General Assembly, implement the Governor's policy priorities across all 17 Executive Branch agencies, and spearhead the state's response to COVID-

19. As a member of the senior staff, Chair Hahn also represented the State of Missouri on the Southern States Energy Board and the Midwestern Higher Education Commission.

Prior to her tenure in the Governor's office, Chair Hahn served as Assistant Director and Research Analyst for the Missouri Senate Division of Research from 2013 until 2018.

Chair Hahn received a Bachelor of Science in political science from Missouri State University and a Master of Arts and Doctor of Philosophy in political science from the University of Missouri-Columbia. Chair Hahn and her family reside in Jefferson City, Missouri.

## Zachary Gladhill, Evergy



Prior to coming to Evergy in 2014, Klindt worked for Axiom Strategies, the largest campaign consulting firm in the nation. Klindt has consulted on Governor, Senate and House campaigns throughout the country. Previously, he served as U.S. Congressman Sam Graves (MO-6) Communications Director for a decade.

In addition to his duties at Evergy, Klindt is a member of the Northwest Missouri State University Board of Regents. He was appointed by the Governor and confirmed unanimously by the State Senate in 2018. In 2025, he was elected to the Kearney R-1 School Board. Klindt lives in Kearney, MO with his wife (Nichole) and their two children (Jacoby and Josephine).

#### Tom Lewis, BlueGreen Alliance

Tom Lewis is a Federal Policy Manager for Manufacturing and Industrial Policy at the BlueGreen Alliance, where he works with the industrial and federal teams, focusing on new investments in clean manufacturing and industrial transformation.

Tom joins BGA from Advanced Energy Economy (AEE). 
#### **Tim Burdis, PJM Interconnection**

Additionally, he managed PJM's engagement with the Organization of PJM States, Inc. (OPSI) and its interaction with the company's Executive Team and Board of Managers.

## Jake Dubbs, Southwest Power Pool (SPP)

Jake Dubbs leads SPP's Government Affairs outreach and engagement efforts for the expanding western footprint. With Government Affairs being part of the External Affairs and Communications team, Jake is highly knowledgeable on the complex make-up of stakeholders that encompass SPP's vast 14 state footprint across the central US. This number is poised to grow soon as SPP will be the first RTO to operate in both the eastern and western interconnection through SPP's RTO West. In addition to Government Affairs, Jake also serves as SPP's advisor on Tribal relations and Tribal energy engagement

As a senior external affairs liaison, Jake proactively works with government

officials and stakeholders to brief them on the intricacies of integrated marketplace mechanics, balancing area authority responsibilities, emergency communication coordination, and key regulatory and legislative dynamics. # Chairperson Andrew French, Kansas Corporation Commission

Andrew French was appointed to the Kansas Corporation Commission by Kansas Governor Laura Kelly in 2020. In 2024, he was reappointed to a second four-year term. French is Kansas's representative to the Southwest Power Pool and regularly participates in SPP stakeholder groups, including the Regional State Committee. He served as President of SPP's RSC in 2023. French also served as a member of FERC's Joint Federal-State Task Force on Electric Transmission for its full duration from 2021 to 2024. Before his appointment to the KCC, French practiced law with a focus on energy policy and the regulation of utility rates and services. He represented a broad spectrum of energy stakeholders, including large industrial energy customers, school districts, and a natural gas utility company. Prior to his work in private practice, French was a staff litigation attorney with the KCC. Commissioner French has a degree in
