## Solar Webinar Schedule

#### November 15, 2016: Solar 101

This webinar lays out solar basics including different market niches of utility scale solar PV, rooftop solar PV, community solar, and solar thermal; costs and benefits associated with each and the role of solar in grid modernization.

#### December 6, 2016: Consumer Perspectives

Business and residential customers can have very different perspectives on solar energy and customer demands are changing quickly. Some businesses are including access to solar and other renewable energy in their siting decision-making, or investigating resiliency benefits of on-site solar plus storage.

#### January 10, 2017: Economic & Workforce Development Opportunities

The webinar will explore options for states to take advantage of a new and growing market—solar manufacturing and installation—accompanied by workforce development opportunities and challenges.

#### February 7, 2017: State Policy Options

Different policies incent or discourage different types of solar development, and different types of solar development present significantly different value propositions that affect grid modernization priorities and design. Policy makers and commissions have taken different approaches with different results. The webinar will include a participant poll to identify areas of interest for in-person meeting.
